- All **new** students must undergo an **assessment** before they can start the program. Please contact the Program Manager, Becca Levick (902-423-0577 or links@chisholm4children.ca), upon enrollment to arrange an assessment time. Assessments will take place via a video meeting between the hours of 10:00 am and 3:00 pm Monday through Thursday.
- Students must have access to a reliable internet connection. Students must have access to a device capable of running Google Suite and in-browser apps.
 - if not already integrated into their primary device, students will need access to headphones/speakers, a microphone, and a camera,
 - Smartphones are discouraged as a primary device due to limitations posed by screen size.
- The Fall Term runs for 20 sessions. A calendar will be provided to you when you register.
- Should sessions need to be rescheduled by caregivers, LINKS allows for one make-up session per student, arranged during the allotted times by caregivers and instructors to best accommodate each party's needs.
